# ADMISSIONS POLICY 2018-19

#### Introduction

St Thomas of Canterbury School, is a Catholic Primary School in the Diocese of Hallam working in partnership with St Marie's and St Wilfrid's Catholic Primary Schools within Our Lady Seat of Wisdom Umbrella Trust.

The school provides distinctive Christ centred, Catholic education for children aged 4+ to 11+ years, with priority being given to Catholic children who live within the feeder parishes as identified in Footnote 1.

As a Catholic Voluntary Academy, the school's Governing Body is responsible for admissions. Governors are guided in that responsibility by the requirements of law and the requirements of the Trust Deed, taking advice from the Diocesan Trustees and bearing in mind their duty to the Catholic community and the Common Good.

## The Published Admission Number (PAN) for 2018/19 is 30

This number has been calculated according to the capacity of the school, which the law defines.

## **Co-ordinated Scheme for Admission Arrangements**

The co-ordinated scheme for admissions is a mechanism that ensures that all parents/carers resident in Sheffield Local Authority who have submitted an application before the closing date will receive a single offer of a school place from the Authority.

Details of the co-ordinated scheme can be obtained from the Authority.

# Applications are made by the completion of the COMMON APPLICATION FORM and the Diocese of Hallam ADDITIONAL INFORMATION FORM, both of which are to be found in the LOCAL AUTHORITY ADMISSION BOOKLET and on the SHEFFIELD COUNCIL WEBSITE.

# **Parental Preference**

The Local Authority Common Application Form provides the opportunity for parents/carers to express up to three choices of schools in rank order of preference. Parents/carers are invited to submit up to three ranked preferences on the Local Authority's Common Application Form. Applications will be considered on an Equal Preference basis; ranking by preference will only be used in the final allocation for a place where there is more than one potential offer.

# Please note that admission to the school does not guarantee eventual admission to one of the Catholic High Schools, which have their own admission policies.

# The date of Admission to the School for 2018/19 is September 2018

Although the law does not require children to be admitted to school until the beginning of the term following their fifth birthday, in 2017/18 parents will be given an option for their child to enter the primary reception class full or part time from the September after their fourth birthday, choosing for them to start in September or to remain in nursery till January or Easter. The school will consult with any parent who wishes to discuss their choice for their child in the event that they may wish to defer until later in the year or until the end of the term in which the child reaches compulsory school age. If no alternative is requested the Governing Body being the admissions authority for this school, will admit all children into school in September.

# PLEASE CONTACT THE SCHOOL IF YOU NEED ANY HELP IN APPLYING FOR ADMISSION

#### Criteria for Admission:

Please note that children who have a Statement of Special Educational Needs or Education Health and Care Plan that names the school are required by law to be admitted.

Where there are more applications for admission than the Published Admission Number stated (see above) the Governing Body will apply the following criteria in strict order of priority:

## St Thomas of Canterbury School

## Category One

Catholic children (see footnote 2) who:-

- a) are Looked After Children or previously Looked After Children (footnote 4)
- b) are siblings (footnote 5) of Catholic children attending the school at the time of admission
- c) live within the feeder parishes for the school (footnote 1)
- d) live within other parishes

## **Category Two**

Looked After Children or previously Looked After Children who are not baptised Catholics.

## Category Three

Children who are not baptised in the Catholic faith but have siblings attending the school at the time of admission.

## **Category Four**

Children who are members of:

- a) Orthodox Churches as recognised by the Catholic Church (footnote 6) who have sought the written support of their minister and live within the feeder parishes for the school
- b) Other Christian denominations (footnote 7) at the time of application, whose parents/carers have sought the written support of their minister and live within the feeder parishes for the school
- c) Orthodox Churches as recognised by the Catholic Church who have sought the written support of their minister and live outside the feeder parishes for the school
- d) Other Christian denominations at the time of application, whose parents have sought the written support of their minister and live outside the feeder parishes for the school

#### Category Five

Children who are members of other World Faiths whose parents/carers wish their children to be educated in a Christ centred environment and have the written support of their Religious Leader.

#### Category Six

Children with a specific educational, medical or emotional need, who do not fall into any of the above categories, provided that appropriate written evidence from a suitably qualified professional, e.g. Doctor or Social Worker, is submitted with the application indicating why that school is the most appropriate setting.

#### Category Seven

Children whose parents/carers are seeking a Christian environment for their children's education.

# **Category Eight**

Other children

The Governing Body will, where possible, admit twins and all siblings from multiple births where one of the children is the 30<sup>th</sup> child admitted.

In the event of the school reaching capacity mid category, the Governing Body as Admissions Authority will allocate places for all the children in that category using a random allocation process which will be overseen by the Local Authority Primary Admissions team. The names of the children who fall within this category will be entered into a computer program specifically designed to randomly allocate the places available.

# FOOTNOTES AND DEFINITIONS

#### Footnote 1.

**The feeder parishes** of St Thomas of Canterbury school are The Holy Spirit (Dronfield) and Our Lady of Beauchief and St Thomas of Canterbury.

## Footnote 2

**Catholic children** are children who have been baptised into the Roman Catholic Church, those formally received into the Roman Catholic Church, Catechumens, Candidates for Reception (those formally preparing to be received into the Roman Catholic Church) or those members of Churches who are in Full Communion with the Roman Catholic Church.

## Definition of a Catechumen

Catechumens are those children who have expressed an explicit desire to be baptised into the Roman Catholic Church and who are currently preparing to receive the same by regular participation in Sunday worship and a recognised programme of preparation.

## Definition of a Candidate for Reception

Candidates for Reception into Full Communion with the Roman Catholic Church are already baptised in another Christian Tradition, who have expressed an explicit desire to be incorporated into the Roman Catholic Church and who are currently preparing to be received into the Church by regular participation in Sunday worship and a recognised programme of preparation.

It is advisable that records of any such reception or incorporation are maintained by the parish.

# Footnote 3

**An Education, Health and Care Plan** is a plan made by the local authority under section 37 of the Children and Families Act 2014, specifying the special educational provision required for a child.

#### Footnote 4

A Looked After Child is a child who is (a) in the care of a local authority, or (b) being provided with accommodation by a local authority in the exercise of their social services functions (Sect 22(1) of the Children Act 1989). A previously Looked After Child is a child who immediately after being looked after became subject to an adoption, residence or special guardianship order.

#### Footnote 5.

**Siblings** are defined as children who live as brother or sister in the same house, including natural brothers or sisters, adopted brothers or sisters, stepbrothers or sisters and foster brothers and sisters.

Footnote 7

**Children of other Christian denominations**, as defined by the Catholic Education Service (CES), are children who belong to other churches and ecclesial communities which, acknowledging God's revelation in Christ, confess the Lord Jesus Christ as God and Saviour according to the Scriptures, and, in obedience to God's will and in the power of the Holy Spirit commit themselves: to seek a deepening of their communion with Christ and with one another in the Church, which is his body; and to fulfil their mission to proclaim the Gospel by common witness and service in the world to the glory of the one God, Father, Son and Holy Spirit. An ecclesial community which on principle has no credal statements in its tradition, is included if it manifests faith in Christ as witnessed to in the Scriptures and is committed to working in the spirit of the above.

All members of Churches Together in England and Churches Together in Wales (CYTUN) are deemed to be included in the above definition, as are all other churches and ecclesial communities that are in membership of any local Churches Together Group (by whatever title) on the above basis.

# Place of residence

A child will be deemed to live at the residential property at which the parents or persons with parental responsibility for the child reside at the closing date for receipt of applications for admission to the school.

Where parental responsibility is held by more than one person and those persons reside in separate properties, the child's ordinary place of residence will be deemed to be that property at which the child resides for the greater part of the week.

# Late Applications

Late applications will be dealt with in accordance with the LA coordinated admissions procedure.

# Waiting List

- 1. If children are refused admission to the school their names will be placed on a waiting list which will be established on the offer day. The waiting list is determined according to the Governing Body's priority of admission over-subscription criteria. Each category on the waiting list will be subject to the random allocation process.
- 2. Following the offer day, should an application be received for that school for a child with a higher priority, as determined by the admissions criteria for a place at the school, they will be placed on the list above those with a lower priority.
- 3. A vacancy only arises in the Reception year when the number of offers of admission to the school falls below the admission number.

# False Information

- 1. Where the Governing Body has made an offer of a place at the school on the basis of a fraudulent or intentionally misleading application from a parent/carer, which has effectively denied a place to a child with a stronger claim to a place the offer of a place may be withdrawn.
- 2. If a child starts attending the school on the basis of fraudulent and intentionally misleading information the place may be withdrawn by the Governing Body, depending on the length of time that the child has been at the school.
- 3. Where a place or an offer has been withdrawn, the application will be reconsidered by the Governing Body and a right of independent appeal offered if a place is refused.

# Applications outside the normal admissions round

Applications outside the normal admissions round will be dealt with in accordance with LA procedures.

# Appeals against the Governing Body's decision to refuse admission

- 1. If a place is not available at the school, parents/carers have the right of appeal. Such appeals against non-admission will be heard by an Independent Appeals Panel formed in accordance with the DfE Admissions Appeal Code. Details of the appeals process will be made available to all unsuccessful applicants
- Parents/carers who intend to make an appeal against the Governing Body's decision to refuse admission must submit a notice of appeal, by the date specified in the refusal letter, to: Democratic Services Sheffield City Council Town Hall Sheffield S1 2HH

Appeal hearings will be held in accordance with the timescales specified in the DfE Admission Appeals Code.

# **Timetable**

Details of key dates within the Admissions process are published on the Sheffield City Council Website.

# **Documentation Required**

The school requires additional information not contained on the Common Application Form. The documentation is obtainable in the LA admission booklet and on the Sheffield Council's website. This additional information is required in order to place applications in the correct priority of admission category.

- The Additional Information Form
   This should be completed, securely attached to the Common Application form and returned to
   the LA by the closing date with a copy of the child's baptism certificate if the applicant is Roman
   Catholic
- 2. A Minister's/Religious Leader's Reference This is required if the child is a member of another Christian denomination or other World Faith.

The Additional Information Form is not an application for admission to the school and its return does not guarantee a place at the school, however failure to complete and return the Additional Information Form may affect the admission category in which the application is placed.
